Vaccination done for residents of Antoine-Labelle and Argenteuil's long-term care facilities (CHSLD)

Saint-Jérôme, January 15, 2021 – The Centre intégré de santé et de services sociaux (CISSS) des Laurentides is pleased to announce that vaccination against COVID-19, for residents of long-term care facilities (CHSLD) in the Antoine-Labelle and Argenteuil MRCs has been completed, as of January 11 and January 12, 2021, respectively.

The first doses of Moderna's vaccine received have enabled the CISSS to administrate the vaccine to 385 residents of the MRCs who consented to this injection. The second dose will be administered according to Public Health guidelines.

In Antoine-Labelle, 175 doses were administered to the residents of the CHSLD L'Équip'Âge, in Rivière-Rouge, and the residents of the Centre d'hébergement de Sainte-Anne, in Mont-Laurier. In Argenteuil, the residents from the Lachute Residence as well as those of the Unités du Pavillon et de La Fontaine, situated inside the Centre multiservices de santé et de services sociaux d'Argenteuil in Lachute, received around 210 doses.

A second batch of Moderna vaccines is also scheduled to be delivered in the next few days. These vaccines will enable the CISSS to complete its vaccination schedule in all long-term care facilities (CHSLD) in the Laurentians, which should be completed on January 20, 2021. Vaccinations at these locations will be reserved for the residents of those facilities. **Priority groups** for vaccination are based on the recommendation of Quebec's immunisation committee and the goal is to prevent serious illness and deaths.

« The CISSS des Laurentides is sparing no effort to ensure the most vulnerable individuals and our healthcare personnel are protected as soon as possible. At the same time as vaccinations proceed for our most vulnerable individuals, vaccinations will continue for healthcare workers in close contact with them. It therefore continues to be crucially important to maintain strict adherence to infection protection measures, even for people who have been vaccinated, as long as new guidelines have not been issued by the Public Health authorities, » said the President and Executive Director of the CISSS des Laurentides, Ms. Rosemonde Landry.

As of January 15 at 1:00 PM, 7131 doses of the COVID-19 vaccine have been administered in the Laurentians.
